


### Why should NGOs Participate?

## **How to on-board Corporates**

- Compile list of past collaboration companies.
- Research recent CSR involvement of potential supporters.
- Involve your board to introduce you to the right person
- Build connection with the right corporates, meet multiple corporate partners and pitch your organization.
- For past VDHM NGOs, reach out to supporting corporate partners.
- Share impact details to showcase fund utilization and impact.

#### Prepare a pitch

- Introduction of your organization and VDHM
- Benefits for the corporate
- VDHM as employee engagement tool
- VDHM will fulfill the CSR requirements
- Proposal for how the funds will be utilized
- Show the benefits the company and its employees will receive
- What are the engagement activities that you can have with corporate employees beyond the race day.
- Volunteering opportunities that the corporate can partake.
- Details of the race day corporate tent and exclusive activities provided.
- Make a race day plan for these runners





## Social Impact Contributors

- Social Impact Contributors are individuals who are champions for the NGOs to further their cause.
- These individuals support the NGO to mobilise support
- The contributors receive recognition at VDHM based on the varying levels of their dedicated support, highlighting their passion.

# **Young Leader**

#### **Criteria:**

- Individuals 18 years old or younger
- Raise donations of INR 75,000 or more.

#### **Benefits**

- Complimentary running bib for the Great Delhi Run
- ➤ Personalized 6-digit number of their preference
- ➤ Certificate in recognition.
- The top 10 Young Leaders are recognized on LinkedIn by United Way Delhi and VDHM.





# **Charity Bib**

PROCAM allocates charity slots for runners, available upon minimum donation to support NGOs.

A half marathon runner who wants to avail a charity bib, is exempt from timing pre-qualification for the race category. (This offer is exclusively for those availing a half marathon charity bib).

#### **Assigning Charity Bibs to the Donor**

- One Charity Bib will be assigned to each NGO
- NGO needs to have a donor to avail the charity bib
- In case an NGO wants to avail more charity bibs they should ensure that they have donor
- The run registration fee has to paid to Procam International by the runner
- Until running slots are available NGOs can avail charity bibs
- If a donor fails to complete run registration then their participation is cancelled (All donations are non-refundable)





## **Top-up Donations**

- During run registration at <a href="https://vedantadelhihalfmarathon.procam.in">https://vedantadelhihalfmarathon.procam.in</a>, participants can now contribute to listed NGOs with United Way Delhi.
- Only local contributions are accepted.
- Runners can donate any amount to their chosen NGO during registration; unselected donations go to a shared pool with UWD.
- Donations from the shared pool are distributed among NGOs based on privilege levels attained.




